RACE DESCRIPTION: You will have your choice of two separate directions to run. Up stream or down stream (towards Oil City or towards Belmar). Giving you the opportunity to race your favorite section of the Samuel Justice trail. It's your choice. Please do not be alarmed. You don't have to race the entire 32 miles of trail to take in the natural beauty of the river and woodlands around you. 2,500 meters out and back of flat, smooth, asphalt surface will do the trick.
